Clark moved to enter into executive session for non-elected personnel for 10 minutes in order to protect employee confidentiality to discuss employee job performance with the Board, County Attorney and County Clerk starting at 10:24 a.m. and reconvened, in the courtroom at 10:34 a.m. Faulkner second the motion with Barnett making it unanimous.

Barnett made the motion to approve vouchers for the amount of \$90,319.03.

Faulkner made the motion to appoint Justin Clark to the SEK Multi County Health Board. Faulkner second the motion, with Barnett making it unanimous.

Clark made the motion to appoint Barnett to be on the Chamber of Commerce Board. Faulkner second the motion, with Barnett making it unanimous.

Clark made the motion to appoint Faulkner to the Tourism Board. Faulkner second it, with Barnett making it unanimous.
