Ambulance Director Cari Cavender presented to the board her weekly Ambulance Run Log. A CPR manual has been ordered. A CPR classed is being planned for county employees and the public once Cavender takes her CPR class.

Clark Second it, with Barnett making it unanimous.

Faulkner made the motion to sign the environmental service agreement for the allocation amount for \$23,000 for 2021. Clark second it, with Barnett making it unanimous.

Bud Moore and Stephanie Bedell came to the board to discuss a zoning commission issue. An open meeting and a couple of closed meetings has been held in regards to the Still Water Lake zoning issue. Mr. Moore explains to build almost anything except a fence you need a permit. County employees graveled the road entrance and Jarrod McVey was asked to go out and work on sewer issues at the residence in question. Mr. Moore wants to know why no county employees asked if they had a building permit. Bedell is just requesting more communication between departments and directly with the zoning board when a building permit, water line, whistle, or other things of that nature is requested.

Clark made a motion to allow the chair to sign the budget and expenditure request for the courthouse and commissioners. Faulkner second it, with Barnett making it unanimous.

Clark made the motion to approve the request for funding from the tourism fund for the amount of \$1,494.57 for repairing the bleachers at the saddle club arena for the Yates Center Day's Bull Bash. Faulkner second it, with Barnett making it unanimous.

Clark made the motion to approve the request for \$1,102.20 out of the tourism fund to help offset the cost of hosting the Highschool Track Meet. Faulkner-second it, with Barnett making it unanimous.

Faulkner moved to adjourn the meeting at 10:32 a.m. Clark second it, with Barnett making it unanimous.
