

Woodson County Resolution # 13-02

A RESOLUTION CONCERNING THE SALARY AND COMPENSATION OF EMPLOYEES AND OFFICERS OF WOODSON COUNTY FOR THE YEAR 2013.

BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS OF WOODSON COUNTY, KANSAS that by a majority vote of the Board of County Commissioners sitting in regular session on the 11 day of April, 2013 adopt the following provisions concerning compensation and salary of employees and elected officials of Woodson County, Kansas for the 2013 to wit:

1. That all full-time salaried employees, elected officials, and officers including the Woodson County Sheriff and the Woodson County Sheriff Undersheriff and Detective shall for the year 2013 receive a 2% of yearly wages/salary plus an additional \$35.00 a month salary increase with said salary increase effective the first payroll period of May 2013.
2. That all part-time salaried employees and officials of Woodson County, Kansas including the Rural Fire #1 Chief shall receive a 2% of yearly wages/salary plus an additional \$35.00 a month pay increase effective the first payroll period of May 2013.
3. That all full-time hourly employees of Woodson County, Kansas shall receive a pay increase of 2% of yearly wages/salary plus an additional \$.25 per hour effective the first payroll period of May 2013.

Full time hourly employees being defined as those employees of Woodson County, Kansas working forty hours or more per week on a regular basis through the year.

4. That all part-time hourly employees of Woodson County, Kansas shall receive a pay increase of 2% of yearly wages/salary plus an additional \$.25 per hour effective the first payroll period of May 2013.

Part-time hourly employees being defined as those employees regularly scheduled employees who work throughout the entire year.


5. That this resolution applies to all employees and elected officials as defined in paragraphs 1-4. Specifically excluded from this resolution are volunteer personnel paid per shift as Ambulance Volunteers, not elsewhere classified, or the Rural Fire #1 Volunteers that are paid per meeting.
6. That should the Board of County Commissioners of Woodson County, Kansas wish to readopt the provisions provided for herein for any subsequent years that may do so by passing a motion readopting this resolution rather than adopting a similar resolution in subsequent years.

7. This resolution shall take effect upon publication one (1) time in The Yates Center News.
