RESOLUTION NO. 16-02

A RESOLUTION ESTABLISHING A 25 MILES PER HOUR MAXIMUM SPEED LIMIT ON A PORTION OF COUNTY ROADS 200TH ROAD AND WILLOW ROAD (MAIN STREET) WITHIN NEOSHO FALLS, KANSAS

WHEREAS, Woodson County has Home Rule and statutory authority to modify speed limits under K.S.A. 19-101a and K.S.A. 8-1560; and

WHEREAS, pursuant to K.S.A. 8-1560, local authorities may determine and declare a reasonable and safe maximum speed limit for roads under their jurisdiction; and

WHEREAS, CFS Engineers has reviewed the area in question and recommended that the maximum speed limit remain 25 miles per hour within the city limits of Neosho Falls, Kansas.

WHEREAS, upon due consideration, the Board of County Commissioners of Woodson County, Kansas have determined that it is in the best interest of the public's health, safety and welfare to adopt the recommendations of CFS Engineers with regard to the area in question.

NOW THEREFORE, be it resolved by the Board of County Commissioners of Woodson County, Kansas that a maximum speed limit of 25 MPH shall be established for all of Main Street of Neosho Falls, Kansas, for that portion of 5th Street commencing at the intersection of 5th and Main Street and going west to the city limits of Neosho Falls, Kansas, and for that portion of 7th Street commencing at the intersection of 7th and Main Street and going east to the city limits of Neosho Falls, Kansas.

BE IT FURTHER RESOLVED that signs designating said speed limits shall be posted by Woodson County Public Works at appropriate locations on the county road right-of-way. This resolution shall become effective upon publication in the official county newspaper and posting of said signs.

BE IN FURTHER RESOLVED that all speed limits established by any previous resolutions for the locations described above which are in conflict with the speed limits established herein, are rescinded and declared null and void and the speed limits established by this resolution shall control.

BE IT FURTHER RESOLVED that from and after the effective date of this Resolution, no person shall operate a motor vehicle on or over any street or roadway designated in this Resolution at a speed in excess of the posted speed limit established by this Resolution and any violation of the provisions of this Resolution by any person, shall be punishable upon conviction by a fine in an amount and in accordance with the provisions of K.S.A. 8-2118(c) and any amendments thereto.
