RESOLUTION NO 11-03



WHEREAS, there are no revenue bond ordinances or other ordinances or resolution of said municipality which require financial statement and financial report to be prepared in conformity with said act for the year ended 2011.

NOW, THEREFORE BE IT RESOLVED, by the County Commissioners of Woodson County, Kansas, in regular meeting duly assembled this 10 day of March, 2011 that said Woodson County Commissioners requests the Director of Accounts and Reports to waive the requirements of said law as they apply to the County of Woodson, Kansas, for the year ended 2011.

BE IT FURTHER RESOLVED that said Woodson County Commissioners shall cause its financial statements and financial reports of the said municipality to be prepared on the basis of cash receipts and disbursements as adjusted to show compliance with the cash basis and budget laws of this State.
