**A Resolution of the Board of County Commissioners of Woodson County, Kansas
Adopting an Interlocal Agreement Between the County and Other Counties to Create the
Southeast Kansas Solid Waste Operating Authority and Rescinding Resolution No.**

WHEREAS, Woodson County, Kansas desires to become a member of the Southeast Kansas Solid Waste Operating Authority, a separate legal entity created pursuant to the Interlocal Cooperation Act, K.S.A. 12-2901 et seq., and

WHEREAS, the Woodson County Board of County Commissioners has studied and approved the document which creates that entity, titled "Interlocal Cooperation Agreement creating the Southeast Kansas Solid Waste Operating Authority" and

WHEREAS, K.S.A. 12-2904(b) requires the County Board to take action by resolution, in order for such an Interlocal Agreement to take force and effect,

THEREFORE, BE IT RESOLVED THAT:


Section 1. The Board of County Commissioners of Woodson County, Kansas joins with those other counties identified in the Interlocal Agreement to create the Southeast Kansas Solid Waste Operating Authority and hereby becomes a member of the Southeast Kansas Solid Waste Operating Authority.

Section 2. The County Board hereby adopts the Interlocal Agreement for the Southeast Kansas Solid Waste Operating Authority. Such agreement is hereby incorporated by reference, as provided by K.S.A. 12-3301 et seq., and shall be as much a part of this resolution as if set out fully herein.

Section 4. This resolution is adopted under the authority of the Interlocal Cooperation Act, K.S.A. 12-2901 et seq. and the Solid Waste Act, K.S.A. 65-3401 et seq., this 30th day of January, 1996.

WHEREAS, Woodson County, Kansas by its adoption of Resolution No. 96-03 has become a member of the Southeast Kansas Solid Waste Operating Authority, and

WHEREAS, Woodson County, Kansas has further adopted the Interlocal Cooperation Agreement of the Southeast Kansas Solid Waste Operating Authority, and

WHEREAS, Section 7.6 of that Interlocal Agreement provides that the initial Bylaws for the Operating Authority shall be adopted by resolution of the Board of County Commissioners of each county belonging to the Operating Authority,
